Findings and recommendations are shared with relevant partners and stakeholders to drive corrective actions.

Capacity Building

- We conduct comprehensive gap analyses and internal assessments, with a special focus on gender equality, workplace harassment, and discrimination. Our findings are systematically reported to relevant partners and stakeholders, forming the basis for corrective action plans. We also provide targeted training and advisory support, helping organizations address these challenges through effective root cause analysis.

- Addressing sensitive issues like sexual harassment and violations of freedom of association requires a nuanced approach. Workers often hesitate to report such incidents due to fear of stigma or retaliation. To mitigate these risks, we integrate advisory services and training programs that build the capacity of organizations to recognize, prevent, and proactively address these challenges, ensuring safe and inclusive workplaces.
- Our factory-level assessments follow a structured and rigorous evaluation process, covering key labor standards. We gather information through document reviews, workplace observations, and interviews with multiple stakeholders, including managers, supervisors, workers, and union representatives. This approach ensures compliance with industry standards while identifying areas for improvement.
- Gender-sensitive approaches are embedded in all aspects of our assessments, training, and advisory services. We ensure that issues related to gender diversity, workplace discrimination, and social stereotyping are addressed through concrete, actionable interventions.

Programme Planning and Implementation


